





PBB/PBDE Testing Flow Chart



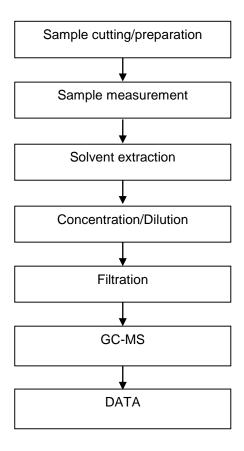



Halogen Testing Flow Chart








